Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Wuehler offered prayer. Woodruff called the meeting to order at 9:00 A.M.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Hewgley, seconded by Wuehler to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on January 23, 2023. Upon roll call vote Hewgley, Wuehler, Bruns and Woodruff voted "aye". Nays, none. Weems abstained.

Motion by Wuehler, seconded by Weems to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Wuehler, seconded by Hewgley to approve the special designated liquor permit submitted by Skyline Liquor LLC for a fundraiser at Harbor Lights on February 10, 2023. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Wuehler to adopt Resolution 2023-03 adding an additional depository to the Lincoln County depositories for 2023. Upon roll call vote Hewgley, Wuehler, Bruns and Woodruff voted "aye". Nays, none. Weems abstained.

The Lincoln County Board of Commissioners recessed at 9:17 A.M. and the Lincoln County Board of Equalization convened.

County Assessor, Julie Stenger appeared along with County Treasurer, Alex Gurcuillo.

Motion by Wuehler, seconded by Hewgley to approve the minutes regarding the Lincoln County Board of Equalization meeting held on January 23, 2023. Upon roll call vote Hewgley, Wuehler, Bruns and Woodruff voted "aye". Nays, none. Weems abstained.

No certificates of correction or refund submitted by the County Assessor.

Motion by Weems, seconded by Bruns to approve the motor vehicle tax exemption application submitted by West Central District Health Department as recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Wuehler, seconded by Bruns to approve the motor vehicle tax exemption application submitted by Maria Evangelical Church of Hershey as recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Equalization adjourned at 9:22 A.M. and the Lincoln County Board of Commissioners reconvened.

Brandon Myers, Region 51 Emergency Management, gave his report for the quarter ending December 2022.

Motion by Wuehler, seconded by Hewgley to accept the bid for a new/used tractor for the Lincoln County Department of Roads from Miller Repair LLC for a 2023 McCormick X7620 in the amount of \$129,930 with the addition of the premium extended (5 year or 5000 hour) warranty for \$12,000 for a total purchase price of \$141,930. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Weems, seconded by Bruns to approve a 5-year service contract with Vanguard Appraisals Inc. for the CAMAvision system for the Lincoln County Assessor. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Commissioner Hewgley reported he had been working on the rural ambulance agreement with the Mayor and the Fire Chief to replace the prior five-year agreement. The City of North Platte will do interlocal agreements with the villages and rural fire districts rather than the county.

Motion by Hewgley, seconded by Weems to approve a 5-year interlocal agreement with the City of North Platte for rural ambulance services. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Gary Person, North Platte Area Chamber & Development Corporation, told board members that the grant application would be to widen Highway 30 and add turning lanes at the Greenbrier entrance. There is an ag-related industry that is looking at this location. The application is due February 1st. A traffic study will need to be completed. There is a 25% match for this grant. The Chamber would pay for the study, match, and other associated expenses.

Motion by Hewgley, seconded by Bruns to approve the North Platte Area Chamber & Development Corporation to prepare a grant application for the Economic Opportunity Program in the amount of \$500,000 from Nebraska Dept. of Transportation and county board chairman to sign the grant application. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Hear concerns from Elected Officials, Department Heads, or their representative.
