Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Woodruff offered prayer. Woodruff called the meeting to order at 9:00 A.M.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Weems, seconded by Bruns to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on January 30, 2023. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Weems to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Wuehler to receive and order filed the fee reports submitted by the County Clerk for \$490 and Clerk of District Court for \$8560.56. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

County Assessor, Julie Stenger appeared along with Alex Gurciullo, County Treasurer.

Motion by Weems, seconded by Bruns to approve the motor vehicle tax exemption application by North Platte Baptist Church as recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Wuehler to approve the motor vehicle tax exemption application by Riverside Baptist Church as recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none

Motion by Hewgley, seconded by Wuehler to approve the motor vehicle tax exemption application by the Salvation Army as recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted “aye”. Nays, none.

Motion by Wuehler, seconded by Hewgley to approve the motor vehicle tax exemption application by American National Red Cross as recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted “aye”. Nays, none.

The Lincoln County Board of Equalization adjourned at 9:19 A.M. and the Lincoln County Board of Commissioners reconvened.

Bonnie Erickson appeared to give the County Board information on possible hazards of retrofitting the Trailblazer Pipeline to CO 2. Trailblazer Pipeline has an easement on property owned by her.

Commissioner Wuehler commented that she had listened to an online presentation about the pipeline.

Commissioner Bruns stated that the current pipeline is being retrofitted as was approved by FERC. Lincoln County did a resolution in 2022 in support of the pipeline but had no authority in approval or disapproval.

Commissioner Woodruff said that there are pros and cons to the pipeline, but the County Board felt the pros outweighed the cons.

Motion by Weems, seconded by Bruns to authorize the Chairman to sign the state grant award and special conditions for the Second Opportunity Supplemental 2023 Community-based Juvenile Services Aid Enhancement grant in the amount of \$1,190.00 to purchase 10 Chromebooks for one of the support programs. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted “aye”. Nays, none.
