February 13, 2023 North Platte, Nebraska

Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Jerry Woodruff and County Clerk, Rebecca Rossell. Weems offered prayer. Woodruff called the meeting to order at 9:00 A.M. Commissioner Bruns was absent.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Hewgley, seconded by Wuehler to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on February 6, 2023. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Wuehler, seconded by Weems to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Weems, seconded by Hewgley to receive and order filed the fee report submitted by the Register of Deeds for \$18,864.55. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

County Assessor, Julie Stenger appeared.

Motion by Hewgley, seconded by Weems to approve the minutes regarding the Lincoln County Board of Equalization meeting held on February 6, 2023. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

No certificates of correction or refund submitted by the County Assessor.

The Lincoln County Board of Equalization adjourned at 9:16 A.M. and the Lincoln County Board of Commissioners reconvened.

Noxious Weed Supt., Todd Herndon and Noxious Weed Board Member, Booker Boyer, appeared to discuss purchase authorization for the Noxious Weed Department.

Deputy County Attorney, Tyler Volkmer, explained that elected officials can spend up to \$10,000 and contract in the county's name per state statute. Appointed officials are

supposed to come before the County Board for approval for purchases from \$0 - \$10,000.

Commissioner Weems stated that the weed board is an advisory board and that the County Board should approve purchases. He did not have an issue with granting the Noxious Weed Supt. a certain amount of fiscal discretion.

Volkmer suggested he prepare a written resolution authorizing the Noxious Weed Supt. up to \$10,000 at the next meeting.

Commissioner Hewgley expressed concern about the weed board authorizing purchases instead of the County Board.

Volkmer replied that the County Board would still be approving the claim for payment.

County Board directed Volkmer to prepare a resolution.

Motion by Wuehler, seconded by Hewgley to set the date for the One- & Six-Year Road Plan public hearing for March 13, 2023, at 10:00 A.M. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

County Board discussed remedy for the HVAC system. It was decided that the remedy process will start with the Building & Grounds committee.

Motion by Hewgley, seconded by Weems to authorize the County Clerk to deposit the HVAC settlement funds (\$500,000) into the county Building Fund. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Weems, seconded by Hewgley to authorize the Chairman to sign (ARPA) State and Local Fiscal Recovery Funds Award agreements with the following: Brady Food Pantry, Deborah's Legacy, Nebraska Youth Center, Bridge of Hope Child Advocacy Center, North Platte Catholic Community Food Pantry, Episcopal Church of Our Savior, North Platte Senior Center, Community Connections of Lincoln County, Families 1st Partnership and Communities for Kids Lincoln County. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

Update by Tanner Pettera of Hub International Insurance concerning the forecasting for renewal premiums. They are predicting a 20% increase in property and a 13% increase in workmen's comp as the experience module went from 1.03 to 1.17. He explained that there were 15 separate one-day weather events in the U.S. last year that caused 1 billion dollars in claims.

Tanner brought a quote from Cowbell Cyber for cyber insurance coverage. This would replace the current coverage the county has through EMC which is a very basic coverage. The quote from Cowbell Cyber is in the amount of \$16,206.77 for 18 months, so it would coincide with the renewal date of August 1 with the other insurance.

Dave Pate, county IT personnel, feels the additional coverage amounts and cost is well warranted. Cyber-attacks can cause substantial monetary loss and down time.

Motion by Hewgley, seconded by Weems to approve the increase in cyber security with Hub International Insurance through Cowbell Cyber in the amount of \$16,206.77 for 18 months of coverage. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

Hear concerns from Elected Officials, Department Heads, or their representative.
