North Platte, Nebraska

Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Woodruff offered prayer. Woodruff called the meeting to order at 9:00 A.M.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Wuehler, seconded by Weems to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on April 10, 2023. Upon roll call vote Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none. Hewgley abstained.

Motion by Weems, seconded by Wuehler to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Commissioner Weems questioned if the County Board would have discretion as to what project this EECBG funding would be utilized on.

Judy Clark replied yes. The county will have to pay the expense up front and then be reimbursed.

Motion by Weems, seconded by Bruns to authorize the Chairman to sign the Pre-Award information sheet for the EECBG (Energy Efficiency & Conservation Grant). Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Wuehler to place on file the fee report submitted by the County Sheriff for \$13,705.00. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Weems, seconded by Bruns to authorize the Chairman to sign the right of way application submitted by Knapp Electric Inc. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

County Treasurer, Alex Gurciullo appeared along with Charity Farley from the County Assessor's Office.

Motion by Weems, seconded by Wuehler to approve the minutes regarding the Lincoln County Board of Equalization meeting held on April 10, 2023. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

No certificates of correction or refund submitted by the County Assessor.

Motion by Hewgley, seconded by Weems to approve the motor vehicle tax exemption application submitted by North Platte Opportunity Center. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Equalization adjourned at 9:17 A.M. and the Lincoln County Board of Commissioners reconvened.

The planning application item was continued until April 24, 2023, due to a typo in the legal description on information forwarded from the Planning Commission.

Mark Hammond represented North 40 Chophouse on two special designated liquor permits.

Commissioner Woodruff asked if the area would be secured.

Hammond replied they would have plenty of staff to secure the area.

Chief Deputy, Roland Kramer, reported that they had no problems last year with an event at this location.

Motion by Weems, seconded by Hewgley to approve and authorize the Chairman to sign the special designated liquor application submitted by North 40 Chophouse for a reception to be held on May 20, 2023, at the Emerald Peak Tent located at 30412 S Effenbeck Rd, Curtis, NE. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Weems to approve and authorize the Chairman to sign the special designated liquor application submitted by North 40 Chophouse for a reception to be held on June 30, 2023, at the Emerald Peak Tent located at 30412 S Effenbeck Rd, Curtis, NE. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Wuehler to approve the participation of Building & Grounds staff and possibly a few inmates from the Lincoln County Detention Center, with the permission of the County Sheriff, for the Downtown Association clean-up day to be held on May 9, 2023.

Commissioner Weems clarified that it would be at the discretion of the Building & Grounds Director to decide who and how they will participate.

Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted “aye”. Nays, none.

Motion by Wuehler, seconded by Weems to approve the special designated liquor permit submitted by Big Red Liquor for a fundraiser at the Lincoln County Fairgrounds on April 28, 2023. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted “aye”. Nays, none.
