Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Bruns offered prayer. Woodruff called the meeting to order at 9:00 A.M.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Hewgley, seconded by Weems to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on May 1, 2023. Upon roll call vote Hewgley, Weems and Woodruff voted "aye". Nays, none. Commissioners Bruns and Wuehler abstained.

Motion by Weems, seconded by Hewgley to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Wuehler, seconded by Bruns to authorize the Chairman to sign the NACO VSP vision insurance plan renewal with a 4-year rate guarantee. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Weems to receive and order filed fee reports submitted by Register of Deeds for \$17,859.75, County Clerk for \$749.00, Clerk of District Court for \$10,768.33, and County Sheriff for \$5039.27. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Wuehler, seconded by Bruns to authorize the Chairman to sign a right of way application submitted by Custer Public Power District. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Bruns to adopt Resolution 2023-09 to amend the Clerk of District Court petty cash fund balance from \$200 to \$220. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Wuehler to adopt Resolution 2023-10 to include additional fees collected for various county services for the Register of Deeds and Veterans Service Officer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Commissioners recessed at 9:17 A.M. and the Lincoln County Board of Equalization convened.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

County Assessor, Julie Stenger appeared along with Alex Gurciullo, County Treasurer.

Motion by Weems, seconded by Hewgley to approve the minutes regarding the Lincoln County Board of Equalization meeting held on May 1, 2023. Upon roll call vote Hewgley, Weems and Woodruff voted "aye". Nays, none. Bruns and Wuehler abstained.

No certificates of correction or refund submitted by the County Assessor.

Motion by Hewgley, seconded by Weems to approve the motor vehicle tax exemption application submitted by the Salvation Army as recommended by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Wuehler, seconded by Weems to approve the motor vehicle tax exemption application submitted by First Baptist Church of Maxwell as recommended by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Weems, seconded by Hewgley to approve the motor vehicle tax exemption application submitted by Bethel Evangelical Church as recommended by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Equalization adjourned at 9:21 A.M. and the Lincoln County Board of Commissioners reconvened.

Commissioner Weems reported that the tentative date set to install the new courthouse generator is over Labor Day weekend. Vendors have asked about the possibility of the county allowing some extra time for the project installation. They are still waiting on some of the necessary components. They will have to completely kill the power to the courthouse for the installation. Some vendors asked to also add all day Friday, September 1st. The board had discussed the possibility of closing at noon on September 1st.

Commissioner Woodruff questioned what would happen if they cannot get unexpected parts over the holiday weekend for the installation and wondered if the county should have a contingency plan for Tuesday, September 5th also.

Commissioner Weems replied that some of the vendors had expressed that concern.

County Clerk, Rebecca Rossell, reminded them that on the legal calendar property taxes are delinquent on September 1st.

Deputy County Attorney, Tyler Volkmer, commented that law enforcement would need to know at least 45 days ahead for court scheduling.

Commissioner Hewgley suggested telling the vendors that they would have the 3-day Labor Day weekend and possibly a ½ day of Friday, September 1st.

Commissioners Bruns interjected that we have approximately 30 days before a final decision needs to be made about September 1st.

Following discussion, it was decided that Plan A would be to close at noon on Friday, September 1st.

Commissioner Hewgley requested that the courts be notified by the County Board with a letter.

Commissioner Wuehler thought a contingency plan for Tuesday, September 5th might be appropriate.

The building and grounds committee will follow up with vendors involved in the installation of the generator.

Hear concerns from Elected Officials, Department Heads, or their representative.
