June 5, 2023 North Platte, Nebraska

Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Weems offered prayer. Woodruff called the meeting to order at 9:00 A.M.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Hewgley, seconded by Weems to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on May 30, 2023, with the correction of USDA representatives name to Barry Johnson. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Wuehler, seconded by Hewgley to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Wuehler to cancel the June 12, 2023, public budget hearing for the amendment to the 2022-2023 fiscal year budget as transfers within the same fund can be done by resolution and the change between funds was not needed. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

County Assessor, Julie Stenger appeared.

Motion by Weems, seconded by Hewgley to approve the minutes regarding the Lincoln County Board of Equalization meeting held on May 30, 2023. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Weems to approve and authorize the Chairman to sign the certificates of correction or refund submitted by the County Assessor concerning eight Brian L. Matthewson TERC cases on real property which previously had confessions of judgment. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Weems to approve and authorize the Chairman to sign the certifications of correction or refund submitted by the County Assessor on real

property due to change in eighteen homestead exemption applications based on information from the Nebraska Department of Revenue. After review by the County Assessor and further review by the Nebraska Department of Revenue using an income audit. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Weems to approve notice of valuation changes submitted by the County Assessor numbered 2023-001 through 2023-012 on real property as listed. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Equalization adjourned at 9:37 A.M. and the Lincoln County Board of Commissioners reconvened.

Motion by Weems, seconded by Wuehler to approve and authorize the Chairman to sign a one-year contract with WebGIS subscription renewal for the County Assessor. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Weems, seconded by Bruns to approve and authorize the Chairman to sign a standard Assessor GIS technical support renewal agreement for one-year for \$16,317.00. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Commissioner Hewgley presented a rough drawing of a 60' X 48' building for discussion. He is suggesting two garage doors and six single outside doors to access conditioned space.

Commissioner Weems asked if evidence vehicles needed to be inside.

Sheriff Kramer replied yes, due to the nature of the evidence.

Weems then asked if there would be room to expand in the future if needed on this site.

Brandon Myers, Region 51 Emergency Management, responded no due to zoning.

Commissioner Wuehler commented she liked that individual storage bays had access from the outside.

Hewgley reported that due to this being an agricultural type of building, an architect/engineer would not be needed for this project.

Commissioner Woodruff wondered about a loft in the building for additional space and how the units would be climate controlled.

Hewgley responded that option would need to be part of the specifications. He would suggest a mini split in each bay for the air/heat.

Board discussed which departments need more storage, how much would need to be climate controlled and security measures. Commissioner Hewgley will work with the Building and Grounds committee to develop specifications.

Deputy County Attorney, Tyler Volkmer, stated that original agreement with Summit Foods had been signed in 2009 and has been amended numerous times. He recommended that the County Board not adopt the proposed amendment and authorize legal counsel to send a letter.

Motion by Bruns, seconded by Hewgley to deny the proposed amendment to the contract with Summit Foods for the Lincoln County Detention Center and authorize the County Sheriff and Deputy County Attorney to engage in discussions with Summit Foods based on the language in the contract. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Discussed what to officially name the Inland Port Authority that encompasses location, culture, and characteristics that imbody the function of the port.

Commissioner Bruns reported that forty-eight names had been submitted for consideration. He reminded board members that this port will be on an international stage.

Commissioner Weems commented that he would like to steer away from generalities. There are thirty-five cities named Lincoln and twenty-four counties named Lincoln in the U.S. He would like to see a descriptive definition that is unique, and he would like to see Nebraska in the name. He thinks it is important to recognize fallen veterans and suggested maybe dedicating the terminal building later.

Commissioner Bruns stated he would like to see the word international in the name.

Commissioner Hewgley suggested inland port did possibly need to be in the name for those that are not familiar with them in the U.S.

Commissioner Wuehler disclosed that she looked favorably upon suggested names with Platte River or Platte Valley in the name but does like having Nebraska in the name.

Motion by Bruns, seconded by Hewgley to approve the official name as Nebraska International Port of the Plains. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Discussed recommendation of candidates by the Inland Port Authority Committee for the Inland Port Authority Board of Directors. The members of the committee are: Gary Person, Tyler Volkmer, Commissioner Bruns and Commissioner Weems. There were twenty-one applicants with outstanding credentials which it made it a very difficult decision. The inaugural board members are going to have a lot of work as there is a vast number of moving parts in the development of the port authority. Several applicants did have to withdraw due to conflicts of interest. They looked for individuals with the following backgrounds: rail logistics, truck & air logistics, legal, financial, infrastructure/construction, agriculture, and business.

Weems reported that the committee had developed a short list of six candidates and that there are many good applicants for the other three slots.

Bruns stated the committee looked at areas of expertise and what will be needed on this board to move forward in the process. The legislature has funds set aside for this project.

Commissioner Woodruff asked if the length of terms would be staggered for the inaugural board.

Bruns replied that that they will be three-year terms and will be staggered.

Commissioner Hewgley wondered if there was a limited number of consecutive terms they could serve.

Bruns responded no.

Gary Person, North Platte Chamber & Development, commented that the candidates had outstanding credentials. If they are not chosen for the inaugural board the door does not close. The Rail Park is encompassed with the port authority.

Bruns told board members that the newly appointed board members will meet over the summer with the help of a consultant and legal counsel. It is possible that an advisory board could be added into the by-laws. The Lincoln County Board of Commissioners will always appoint the port authority board members.

Motion by Bruns, seconded by Weems to appoint the following for a three-year term to the Nebraska International Port of the Plains Board of Directors: Dwight Porter, Vince Dugan, and Kirk Olson. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Weems to appoint the following for a two-year term to the Nebraska International Port of the Plains Board of Directors: Kimberly Steger, Jim Hawks and J. Patrick Keenan. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Weems to appoint the following for a one-year term to the Nebraska International Port of the Plains Board of Directors: LeAnn Ellis, Michael Steele, and Kevin Tighe. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.
