Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Hewgley offered prayer. Woodruff called the meeting to order at 9:00 A.M.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Hewgley, seconded by Bruns to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on June 12, 2023. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Woodruff, seconded by Weems to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Weems to authorize the Chairman to sign an agreement with William Troshynski for legal services from 7-1-2023 to 6-30-2024. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Wuehler to receive and order filed the fee report submitted by the County Sheriff for \$6097.93. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

County Assessor, Julie Stenger appeared along with Alex Gurciullo, County Treasurer.

Motion by Weems, seconded by Hewgley to approve the minutes regarding the Lincoln County Board of Equalization meeting held on June 12, 2023. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Wuehler to authorize the Chairman to sign the certificates of correction or refund submitted by the County Assessor on real property. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Wuehler to approve the motor vehicle tax exemption application submitted by North Platte Opportunity Center as recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Weems, seconded by Wuehler to approve the motor vehicle tax exemption application submitted by North Platte Catholic Schools as recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Wuehler, seconded by Bruns to approve the motor vehicle tax exemption application submitted by American National Red Cross as recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Weems to approve the motor vehicle tax exemption application submitted by Mission Life Inc. as recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Wuehler to approve the notice of valuation changes numbered 2023-13 & 2023-14 as submitted by the County Assessor. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Equalization adjourned at 9:25 A.M. and the Lincoln County Board of Commissioners reconvened.

Motion by Wuehler, seconded by Weems to approve and authorize the Chairman to sign the special designated liquor permit application submitted by Creativity Unlimited Arts Council dba Prairie Arts Center for a wedding reception at Harbor Lights on July 8, 2023. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Wuehler to approve and authorize the Chairman to sign the special designated liquor permit application submitted by Creativity Unlimited Arts Council dba Prairie Arts Center for a wedding reception at Harbor Lights on October 14, 2023. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Mike Schroer of Cork & Cap LLC appeared for his liquor license application at the Fairgrounds. If approved, this would be an annual renewal in the future. He would like to help the Ag Society move in a positive direction for growth and to help control issues.

Commissioner Bruns commented that the NE Liquor Control Commission will only allow applicants so many special designated liquor permits per year and this would streamline that process for events at the fairgrounds.

A public hearing to receive comments on the application for a Class I catering license for Cork & Cap, LLC dba C & C Catering at the Fairgrounds was opened at 9:49 A.M.

Commissioner Weems verified that the applicant went through all the steps necessary for the application.

Sheriff Kramer reported they have always had a problem with alcohol in the pit area at the racetrack.

Schroer stated that the application would include the entire fairgrounds (in the fence) including the camping area and pit area. They would need to have someone on site to monitor and work with the fair board at all events.

Commissioner Hewgley expressed concern with the entire area of the fairgrounds being included and the turnover of the fair board members. He feels it should be limited to a specific area. It would be very difficult to police the entire fairgrounds.

Commissioner Bruns sees it as administrative streamlining for permitting.

Commissioner Hewgley would like the board to consider discussing the location and times of sale at the fairgrounds.

Commissioner Bruns commented that Mike's liquor license is on the line for all his locations, so he is confident that he would insure control with checks and balances.

Commissioner Hewgley said the county can still have language to help control the area.

County Sheriff Kramer told the audience that the real estate will be difficult to control. It will be changing the mind set of people, especially those in the pit area.

Commissioner Woodruff used the NebraskaLand Days arena as an example. It did take time, but the alcohol issues did improve.

Schroer replied that is hoping to change the pattern. He will post that outside liquor is not permitted.

Sheriff Kramer stated that those who do not have a liquor permit for events at the fairgrounds are the ones that get out of control.

Commissioner Wuehler questioned if all employees had or would get alcohol service training.

Schroer responded in the affirmative. He feels it will make it safer to have somebody running the liquor sales at the fairgrounds.

Commissioner Bruns reported that the Ag Society does endorse this application.

The public hearing was closed at 10:17 A.M.

Motion by Bruns, seconded by Hewgley to send a recommendation for approval on the Class I catering license application for Cork & Cap, LLC dba C & C Catering at the Fairgrounds to the Nebraska Liquor Control Commission.

Commissioner Weems stated he was confident that they will police this area and have better oversight.

Commissioner Hewgley questioned if private parties would be able to bring in alcohol.

Schroer replied no.

Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

County Highway Supt., Jason Schultz, told board members that the asphalt bids were all higher than the anticipated budget. He has been holding all capital expenditures in the current budget year and will have 2.2 million to put toward this project in next years budget. He does not want to take a year off for asphalt projects. He recommends that the County Board accept the Option #2 bid of Western Engineering for \$2,642,062.50.

Commissioner Woodruff reiterated due to asphalt prices the road department only did a limited number of miles in the 2022/2023 budget year.

Board discussion was held on the current budget, cash flow, and how this could affect the 2023/2024 fiscal year budget.

Motion by Wuehler, seconded by Bruns to accept the bid of Western Engineering – Option 2 in the amount of \$2,642,062.50 for 2023 asphalt overlay projects for Lincoln County Department of Roads. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Discussed the request of Sheryl Ball, Lincoln County Detention Officer, concerning the North Platte Rocks Kindness Project. Following discussion board members said they support the project and concept but requested that she look at a different location rather the courthouse. There were concerns about safety and vandalism. It was suggested that she contact the Prairie Arts Center as a possible location.

Update by Commissioner Wuehler on the Digital Divide Stockholder Group and West Central Nebraska Development Corporations partnership in the application and grant process. The development districts have combined efforts to submit a written plan to help bridge the digital divide in Nebraska for those that are unserved and underserved to be eligible for funding. It will be important for the county to submit a letter of support as well as a resolution establishing support of the plan.

Hear concerns from Elected Officials, Department Heads, or their representative.
