November 13, 2023 North Platte, Nebraska

Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Wuehler offered prayer. Woodruff called the meeting to order at 9:00 A.M.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Wuehler, seconded by Hewgley to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on November 6, 2023. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Weems, seconded by Hewgley to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Weems to authorize the Chairman to sign the management representation letter to the Nebraska Auditor of Public Accounts for the county audit ending June 30, 2023. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

Chairman Woodruff announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

County Assessor, Julie Stenger appeared.

Motion by Weems, seconded by Wuehler to approve the minutes regarding the Lincoln County Board of Equalization meeting held on November 6, 2023. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

No certificates of correction or refund submitted by the County Assessor.

The Lincoln County Board of Equalization adjourned at 9:16 A.M. and the Lincoln County Board of Commissioners reconvened.

Discussion was held concerning authorizing the Chairman to sign a contract with Cleary for the construction of a storage building for Region 51 Emergency Management. Legal notice was given that the county was considering a special purchase to allow other parties an opportunity to submit a quote. One additional company requested information, but no other quotes were submitted.

Deputy County Attorney, Tyler Volkmer, reminded the board that a payment bond is required. The county board was not opposed to picking up the cost of the payment bond.

Commissioner Weems reminded the board that other items such as water, heat, electrical, etc. would need to be considered later.

Legal counsel will work on a contract with Cleary for erecting the building.

Discussed the change order request for the 111 North Dewey project (Probation Office remodel). Lee Davies, project architect, explained the following changes were made per Change Order 01: a) hidden non code conforming power/lighting circuit modified to meet code; b) additional floor prep due to uneven floors and cracks under existing floors; c) contractor removed cleaning from the project, owner self-clean with painting for \$6694.00 total. These changes had to be done to meet Code, however the change order process was not done correctly.

Motion by Hewgley, seconded by Wuehler to approve and authorize the Chairman to sign Change Order No. 01 for the 111 North Dewey project (Probation Office remodel) for \$6694.00. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Derek Hanna and Dan Newton from the Lincoln County Sheriff's Office appeared along with Sheriff Kramer, Amanda Huebner (Sutherland Public Schools), and Brandy Buscher (Sutherland & North Platte Public Schools) to discuss school resources officer funding. The Sheriff's Office submitted a grant and was approved to receive 80% of new hire wages up to \$125,000 over 3 years. Sutherland Public Schools would absorb the rest of the cost. The deadline for response is December 16, 2023. They are requesting input from the county board and legal counsel.

Commissioner Hewgley questioned what the number of deputies is to be fully staffed.

Lt. Dan Newton replied that they are currently at 20 and are five deputies short now. They can only have two new deputies in the academy at a time. During the summer months this officer could be on regular patrol.

Commissioner Bruns asked if we could train someone in the schools.

Newton replied he was not sure how much the school could do.

Huebner stated there are legalities and protocol that must be followed.

Commissioner Hewgley asked if the school could hire an outside security company.

Huebner responded it would require a policy change, but they could.

Buscher commented she had some thoughts on sustainability and ideas for funding. A school resource officer would be a good resource, could offer professional development for staff and do preventative programming. Rotation might be possible between the school districts.

Newton stated the county could de-obligate the grant funds later if we do accept them.

Sheriff Kramer suggested letting them accept the grant and that gives them until next August to work on programming.

Following discussion, an ad hoc committee will meet with the following stakeholders: Commissioners Hewgley and Weems, Lincoln County Sheriff's Office, Sutherland Public School representatives, and legal counsel to further investigate the viability of the grant program.

Motion by Bruns, seconded by Hewgley to adopt Resolution No. 2023-32 authorizing the sale of real property to the Village of Sutherland as published in the North Platte Telegraph on October 5, 2023. Upon roll call vote Weems, Wuehler, Bruns, Hewgley and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Hewgley to approve an amended interlocal agreement with Sutherland Public School District 55 for transportation services during the construction of the Sutherland North Bridge project which added a provision for possible transportation of a student with mobility challenges. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Commissioner Bruns and Planning Director, Judy Clark, presented a draft Lincoln County Nebraska Community Stakeholder Transportation Feasibility Study and Strategy Development combined request for proposals (RFP) and request for qualifications (RFQ).

It was decided that Commissioners Bruns and Hewgley, Judy Clark, and Jason Schulz will convene the following stakeholders (Nebraska Department of Transportation, City of North Platte, Village of Hershey, Nebraska International Port of the Plains, North Platte Area Chamber and Development Corporation and Nebraska Public Power District) if they are willing to participate, to see if there is a buy in from the other stakeholders to pursue the project and share the cost.

Hear concerns from Elected Officials, Department Heads, or their representative.
