Motion by Wuehler, seconded by Weems to accept the bid of Western Engineering for LCDOR 2023-02 asphalt overlay projects for \$1,550,314.40. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Mike Schroer, applicant for Cork & Cap LLC dba C & C Catering appeared to answer any questions concerning the Class I liquor license application.

A public hearing on the Class I liquor license application submitted by Cork & Cap LLC dba as C & C Catering at Harbor Lights located at 711 E North Lake Rd, North Platte, NE was opened at 9:42 A.M.

County Board noted that the complete application was received from the NE Liquor Control Commission for their review.

Motion by Hewgley, seconded by Weems to send a recommendation to approve to the NE Liquor Control Commission on the application for a Class D liquor license submitted by Fast Stop 1155 Inc. at 381 N Hwy 25, Sutherland, NE. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Discussed authorizing the Chairman to sign a contract with Cleary Building Corp for Region 51 Emergency Management storage building. The building, concrete and doors are included in the contract. Item was tabled for clarification on the interior lining.
