Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Woodruff offered prayer. Hewgley called the meeting to order at 9:00 A.M.

Chairman Hewgley announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Bruns, seconded by Weems to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on February 20, 2024. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Woodruff, seconded by Wuehler to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Woodruff to receive and order filed the fee reports submitted by the County Sheriff for \$4297.63 and \$2378.10. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Weems, seconded by Woodruff to authorize the Chairman to draft a letter in opposition to the proposed closing of the North Platte Mail Processing & Distribution Center. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Wuehler to authorize the Chairman to sign the right-of-way permit submitted by NE Public Power District with proposed route in the application and the permit fee to be billed by Lincoln County Department of Roads. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

Chairman Hewgley announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

County Assessor, Julie Stenger appeared along with County Treasurer, Alex Gurciullo.

Motion by Woodruff, seconded by Bruns to approve the minutes regarding the Lincoln County Board of Equalization meeting held on February 20, 2024. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

No certificates of correction or refund submitted by the County Assessor.

Motion by Weems, seconded by Wuehler to approve the motor vehicle tax exemption application submitted by Great Plains Health and recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Wuehler, seconded by Woodruff to approve the motor vehicle tax exemption application submitted by New Life Assembly and recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Equalization adjourned at 9:18 A.M. and the Lincoln County Board of Commissioners reconvened.

Discussion was held concerning the revised Lincoln County Employees Manual. Elected officials had questions on the illness and injury donation as well as the personal days. County Board tabled the adoption of the manual until the county board committee can meet with elected officials and department heads to review the revised manual.

A public hearing was opened at 10:01 A.M. to receive comments on the Lincoln County One- & Six-Year Road Plan.

Highway Supt., Jason Schultz and Assistant Highway Supt., Brian Glos appeared to present the One- & Six-Year Road plan. Schultz reviewed the completed and carry over projects from 2023. The one- year plan summary and then the six- year plan summary was given.

Jim Boyle requested a rebuild on North Washboard Road.

Commissioner Wuehler asked for the distance on the road.

Boyle replied from North River Road to Suburban Road.

Patrick Thomlison also expressed concern about North Washboard Road, particularly with the culverts and water in the ditches.

Ted Jedrzejek concurred that North Washboard Road needs a rebuild.

Michael Cook gave the board a written statement expressing his concerns about Eugene Avenue.

Eric Seacrest made comments on the proposed plan projects and various other road concerns. He congratulated the county on the progress the county has made in all parts of the county on roads, especially the project in progress on Sutherland North Bridge. He urged attention to also to Eugene Avenue as it is unsafe. He suggested the county look at a possible corridor for a west interchange.

The public hearing was closed at 10:48 A.M.

County Board members made remarks on the proposed plans.

Commissioner Bruns commented that he appreciates the road departments efforts. He stated that the One- & Six-Year Road plans are for major projects not maintenance. The county needs to look at N Washboard Road as well as Eugene Avenue.

Commissioner Woodruff asked about the possible use of grant dollars such as the Safe Streets for All grants.

Commissioner Weems stated the county is always playing catch up on roads. The North Maxwell Road had been in disrepair for a long time. It does not stop at the golf course. He was glad to see that it finally got some attention.

Commissioner Wuehler thanked the road department management and crew for their efforts. It is a tough job to assess and decide what projects are priority.

Motion by Woodruff, seconded by Wuehler to approve the adoption of the 2024 One- & Six-Year Road plan following the public hearing as presented. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Weems, seconded by Bruns to set March 25, 2024, at 10:00 A.M. to accept bids for Lincoln County asphalt project LCDOR 2024-1 with a base bid and alternate #1 Included. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.
