Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Jerry Woodruff and County Clerk, Rebecca Rossell. Wuehler offered prayer. Hewgley called the meeting to order at 9:00 A.M. Commissioner Bruns absent.

Chairman Hewgley announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Weems, seconded by Wuehler to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on March 11, 2024. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Woodruff, seconded by Wuehler to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Wuehler, seconded by Weems to authorize the Chairman to sign the NE Dept. of Revenue County/City Lottery Operation renewal applications for 2024-2026 which authorizes the applicants to conduct the lottery on behalf of the county. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

Chairman Hewgley announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Deputy County Assessor, Pat Collins appeared along with County Treasurer, Alex Gurciullo.

Motion by Woodruff, seconded by Weems to approve the minutes regarding the Lincoln County Board of Equalization meeting held on March 11, 2024. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Weems, seconded by Wuehler to approve the motor vehicle exemption application by American National Red Cross and recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

The Lincoln County Board of Equalization adjourned at 9:18 A.M. and the Lincoln County Board of Commissioners reconvened.

Motion by Weems, seconded by Wuehler to authorize Chairman Hewgley to sign the Lincoln County Agriculture Week Proclamation from March 17 – 23, 2024 extending appreciation to all who have shown dedication and perseverance in growing our state through agriculture. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted “aye”. Nays, none. Bruns absent.

Motion by Woodruff, seconded by Weems to approve and authorize the chairman to sign 2024 professional services agreement with TC Engineering for engineering services pursuant to Neb. Rev. Stat. 81-3445. Upon roll call vote Hewgley, Weems, Wuehler and Woodruff voted “aye”. Nays, none. Bruns absent.

Motion by Weems, seconded by Woodruff to authorize the chairman to sign purchase option notice to North Platte Area Chamber of Commerce and Development Corporation to purchase property located at 18610 Highway 30, Hershey, Nebraska for \$1.00. Upon roll call vote Hewgley, Weems, Wuehler and Woodruff voted “aye”. Nays, none. Bruns absent.
