Ballots will be mailed starting April 8. If your ballot application is received after April 8, please allow 3 to 5 working days for the ballot to be processed and mailed.

New this year: You must provide your Nebraska driver's license or state ID number to comply with Nebraska's Voter ID law, OR you may provide a copy of another valid government-issued ID (passport, military ID, in-state college ID, etc.) or a reasonable impediment certification (call the office or see the website voterid.nebraska.gov for details.)

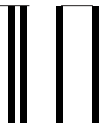
