Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Jerry Woodruff and County Clerk, Rebecca Rossell. Hewgley offered prayer. Hewgley called the meeting to order at 9:00 A.M. Commissioner Bruns was absent.

Chairman Hewgley announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Woodruff, seconded by Wuehler to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on June 10, 2024. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Wuehler, seconded by Woodruff to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

Chairman Hewgley announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

County Assessor, Julie Stenger appeared.

Motion by Weems, seconded by Woodruff to approve the minutes regarding the Lincoln County Board of Equalization meeting held on June 10, 2024. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

No certificates of correction or refund submitted by the County Assessor.

Motion by Weems, seconded by Woodruff to approve the real and personal property tax exemption application submitted by Deborah's Legacy on real property located O.T. 5-90. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

The Lincoln County Board of Equalization adjourned at 9:18 A.M. and the Lincoln County Board of Commissioners reconvened.

The contract with Trinity Food Services for the Lincoln County Detention Center food service was tabled to address additional details of the contract prior to signing.

Chairman Hewgley suggested the County Board Chairman be part of the Nebraska International Port of the Plains committee.

Commissioner Wuehler questioned when it would take effect.

Commissioner Hewgley responded it would be effective immediately.

Commissioner Weems stated he did not see a need for this to take effect at all.

Commissioner Hewgley commented that he had been approached on this subject due to non-participation of the County Board.

Commissioner Weems interjected that Commissioner Bruns has been the liaison between the port and board and has kept him informed and feels the county needs to be hands off.

Commissioner Woodruff reported that he is an outsider concerning the port board and commented that there are already two board members involved.

Commissioner Wuehler said she had been approached about being part of the committee since she attends the meetings. She did state she had heard concerns about the county not being involved as much as they should be.

Commissioner Weems stated that he felt it would be a conflict of interest for Commissioner Hewgley to be involved with the port due to potential additional clients.

Chairman Hewgley appointed himself to the Nebraska International Port of the Plains committee along with Commissioner Bruns at the request of the Inland Port Committee and other county board members.

Deputy County Attorney, Tyler Volkmer, reminded the County Board that the Inland Port Authority is its own entity and is an autonomous body. The County Board no longer has control or influence over the port authority.

The Chairman requested that this item be on next week's agenda again for discussion by the full board to consider if the County Board needs to have a representative on the port authority committee before any formal action is taken.
