June 24, 2024 North Platte, Nebraska

Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Weems offered prayer. Hewgley called the meeting to order at 9:00 A.M.

Chairman Hewgley announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Wuehler, seconded by Woodruff to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on June 17, 2024. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns abstained.

Motion by Woodruff, seconded by Wuehler to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Woodruff to receive and order filed the fee report submitted by the County Sheriff for \$1432.50. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Woodruff, seconded by Wuehler to authorize the Chairman to sign the interlocal agreement with the City of North Platte for fuel services. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

Chairman Hewgley announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

County Assessor, Julie Stenger appeared.

Motion by Weems, seconded by Woodruff to approve the minutes regarding the Lincoln County Board of Equalization meeting held on June 17, 2024. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns abstained.

No certificates of correction or refund submitted by the County Assessor.

Motion by Wuehler, seconded by Woodruff to approve offers to confess judgment on the following case numbers with the Nebraska Tax Equalization and Review Commission: 23R-68; 23R-71; 23R-73; 23R-74; 23R-78; 23R-79; and 23R-80. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Equalization adjourned at 9:19 A.M. and the Lincoln County Board of Commissioners reconvened.

Motion by Bruns, seconded by Woodruff to forward the tort claim for damage to her vehicle as submitted by Denisa Davis to the county insurance carrier. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Weems to approve the updated contribution agreement of \$474,805 total with Dormie Network for the asphalt overlay on North Maxwell Road which will be a 50/50 split with Lincoln County. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Wuehler, seconded by Bruns to approve and authorize the Chairman to sign the 2-year contract with Trinity Food Services for the Lincoln County Detention Center as presented with annual renewals. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Update on Comprehensive Plan for Lincoln County by Judy Clark, North Platte/Lincoln County Planning Director.

Commissioner Hewgley explained the difference between a standing committee and an ad hoc committee. A standing committee is long term. An ad hoc committee is a temporary committee that addresses a specific issue or project. He suggested forming a standing Rules Committee that would initially be tasked with drafting a set of rules for the County Board to consider.

Commissioner Woodruff asked if a transportation committee would the same as the roads committee.

Commissioner Bruns said this committee is more about a possible infrastructure project rather than transportation. An ad hoc committee was formed for that with Commissioners Bruns and Weems.

Commissioner Wuehler asked for clarification on the committee types and past history of County Board committees.

Commissioner Hewgley replied that typically in the past they have been appointed by the County Board chairman.

Commissioner Bruns reported that we already have a Rules Committee that Commissioners Hewgley and Woodruff serve on.

Commissioner Wuehler asked about other committees that you are asked to serve on such as through NACO.

Commissioner Hewgley responded that he feels it is separate from the county and is a personal commitment.

Deputy County Attorney, Tyler Volkmer, commented that you can be on a committee as an individual, but you should clarify that you are not representing the county.

Commissioner Bruns suggested referring to some of these appointments as liaisons and not board members. A liaison reports back and forth but is no a voting member.

Various current committee appointments were discussed.

The Rules Committee will meet and determine the next steps.

Discussion then moved on to the prior agenda item concerning the Nebraska International Port of the Plains.

Commissioner Hewgley stated that he had asked for a motion to form a committee at the May 24, 2021, board meeting but does not believe any official action was taken. Hewgley understands that there is definitely a relationship between the port and the count., but does not feel the county board should manage, micro-manage or participate on the port authority board.

Commissioner Bruns believes that an ad hoc committee was stood up at that time but feels the ad hoc committee has served its purpose. The port authority board is doing well but does feel a standing liaison should be appointed by the County Board to work with the Nebraska International Port of the Plains.

Commissioner Woodruff questioned if there would only be one liaison to the port.

Commissioner Wuehler commented that she felt due to the magnitude of the county financial investment in the port and rail park, she feels that we should have two committee members.

Commissioner Woodruff asked her if she meant committee members or liaisons.

Commissioner Wuehler responded that she sees it more as a committee.

Commissioner Bruns shared that he sees it as literally a liaison position.

Commissioner Weems reported that Pat Keenan had called him. Mr. Keenan does not feel that two committee members should be involved with the port authority.

Volkmer stated that these positions are not statutory, this would be internal board structure.

Commissioner Hewgley interjected that two people can be at the meeting listening so there is communication back and forth.

Commissioner Bruns stated there is an adopted resolution that states the role of the county. County liaison (s) would serve a communication role. There is no need for clarification.

Commissioner Wuehler commented that in her opinion that Commissioner Bruns involvement has been a benefit to the county board. She feels the committee should have two active county board members.

Deputy County Attorney, Tyler Volkmer, stated one person is sufficient. The port authority meetings are a briefing. If there are more than two board members present, in his opinion, that is a county board meeting.

Commissioner Wuehler interjected that the port ad hoc committee has served its purpose. She suggests that Commissioner Bruns be the first member and the County Board Chairman be the second member.

Commissioner Hewgley stated the rules committee would meet and then asked for an agenda item at next week's board meeting to discuss and consider appointing a committee to the Nebraska International Port of the Plains.

Hear concerns from Elected Officials, Department Heads, or their representative.
