Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Hewgley offered prayer. Hewgley called the meeting to order at 9:00 A.M.

Chairman Hewgley announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Wuehler, seconded by Woodruff to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on October 14, 2024. Upon roll call vote Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none. Hewgley abstained.

Motion by Woodruff, seconded by Wuehler to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Weems to receive and order filed the fee report submitted by the County Sheriff for \$5550.96. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

County Assessor, Julie Stenger appeared.

Motion by Woodruff, seconded by Bruns to approve the minutes regarding the Lincoln County Board of Equalization meeting held on October 14, 2024. Upon roll call vote Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none. Hewgley abstained.

Motion by Wuehler, seconded by Woodruff to approve and authorize the Chairman to sign the certificates of correction or refund submitted by the County Assessor on real property. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Equalization adjourned at 9:17 A.M. and the Lincoln County Board of Commissioners reconvened.

Motion by Woodruff, seconded by Weems to approve deeming the following Lincoln County Weeds Department Equipment as surplus and no longer useable by the County: trailer, two tanks, snow blade, plastic toolbox and two 4-wheelers. The County Board

requested that the two 4-wheelers be evaluated for reasonable repair before being offered for sale. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Wuehler, seconded by Woodruff to approve the sale of surplus Lincoln County Weeds Department Equipment as listed above which was deemed surplus and no longer usable by the county. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Woodruff, seconded by Weems to approve and authorize the Chairman to sign the final quantities change order #2 for a decrease of -\$85,281.87 and the final pay application for \$352,126.28 for the North Sutherland Bridge Project. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The following informal bids were received for a sign truck for the Lincoln County Department of Roads: Jody Auto Sales -2015 model - \$28,500; DTI Trucks - 2017 model - \$37,500.00; Bill Summers Ford - 2017 model - \$36,750; and Jody Auto Sales - 2019 model - \$33,995.

Motion by Bruns, seconded by Woodruff to approve the purchase of a sign truck from Jody Auto Sales for a 2015 model for \$28,500 for the Department of Roads. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Emergency Management Director, Brandon Myers and Amanda Snide of UPRR gave an update on a derailment and chemical spill incident on 10/17/2024 at UPRR Bailey Yard. They reported that this incident overall went better than the incident last year. The chemical was in a tank car rather than barrels and had a hazmat coupler. The incident response went smoothly. There was better communication, and the railroad is making progress.

Emergency Management Director, Brandon Myers gave an update on Sommerset Road Fire response as well as two other fires that occurred recently.
