Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Wuehler offered prayer. Vice Chairman Wuehler called the meeting to order at 9:00 A.M. Commissioner Hewgley was absent.

Vice Chairman Wuehler announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Woodruff, seconded by Bruns to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on November 25, 2024. Upon roll call vote Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none. Hewgley absent.

Motion by Bruns seconded by Woodruff to receive and order filed the treasurer's receipts. Upon roll call vote Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none. Hewgley absent.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

The Lincoln County Board of Equalization adjourned at 9:18 A.M. and the Lincoln County Board of Commissioners reconvened.

Update on ARPA grant fund applicants by Commissioner Wuehler. She reported that eight (8) entities had \$105,000 left to spend in October 2024. Four of those have either expended the money or have a plan. The other four entities: The Salvation Army, Hope's Cupboard, Episcopal Church of our Savior and Communities for Kids Lincoln County have been sent a second registered letter asking for a response. There is approximately \$56,000 left to spend with these four entities. Commissioners plan to spend any ARPA funds that are left encumbered by December 31, 2024.

Commissioners Weems and Woodruff gave a committee update on the review of the Lincoln County General Assistance and Medical Assistance Guidelines.
