Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Hewgley offered prayer. Hewgley called the meeting to order at 9:00 A.M.

Chairman Hewgley announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Woodruff, seconded by Bruns to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on January 6, 2025. Upon roll call vote Hewgley, Weems, Bruns and Woodruff voted "aye". Nays, none. Wuehler abstained.

An election was held for County Board Chairperson for 2025. Commissioner Wuehler was nominated by Commissioner Woodruff. Wuehler accepted the nomination. All board members voted "aye" for Wuehler.

An election was held for County Board Vice Chairperson for 2025. Commissioner Woodruff was nominated by Commissioner Hewgley. Woodruff accepted the nomination. Woodruff abstained. All other board members voted "aye".

Motion by Hewgley, seconded by Woodruff to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Woodruff to receive and order filed the fee reports submitted by the County Clerk and County Sheriff. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Weems to receive and order filed the Condition of the Treasury- July 1, 2024, to December 31, 2024. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Woodruff to adopt Resolution No. 2025-01 authorizing the County Treasurer to invest funds for 2025. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

Chairmwoman Wuehler announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

County Assessor Julie Stenger appeared along with County Treasurer, Sheri Newton.

An election was held for Board of Equalization Chairperson for 2025. Commissioner Wuehler was nominated by Commissioner Hewgley. Wuehler accepted the nomination. All board members voted "aye".

An election was held for Board of Equalization Vice Chairperson for 2025. Commissioner Woodruff was nominated by Commissioner Hewgley. Woodruff accepted the nomination. Woodruff abstained. All other board members voted "aye".

Motion by Woodruff, seconded by Hewgley to approve the minutes regarding the Lincoln County Board of Equalization meeting held on January 6, 2025. Upon roll call vote Hewgley, Weems, Bruns and Woodruff voted "aye". Nays, none. Wuehler abstained.

Motion by Hewgley, seconded by Woodruff to approve and authorize the Chairperson to sign the certificates of correction or refund submitted by the County Assessor on real property. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Weems, seconded by Hewgley to approve the motor vehicle tax exemption application by First Baptist Church of Maxwell as submitted and recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Hewgley, seconded by Weems to approve the motor vehicle tax exemption application by Goodwill Industries of Greater NE Inc. as submitted and recommended for approval by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Woodruff to approve the motor vehicle tax exemption application by North Platte Baptist Church as submitted and recommended for approval by the County Treasurer as requested documentation had been provided. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Equalization adjourned at 9:26 A.M. and the Lincoln County Board of Commissioners reconvened.

County Board members discussed the process used for annual department head appointments in the past and how to handle the appointment process in the future.

Motion by Weems, seconded by Woodruff to approve the appointments of the following department heads for 2025: Highway Supt – Jason Schultz – License #1753 – Class B – Full Time Employment – January 1, 2025 – December 31, -2025; Noxious Weed Supt

Todd Herndon; Region 51 Emergency Management Director – Brandon Myers; and Veterans Service Officer- Thomas Gann. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Woodruff, seconded by Bruns to have the Personnel Committee review and bring back to the County Board recommendations on the annual salaries for the following appointed department heads for 2025: Highway Supt, Noxious Weed Supt, Region 51 Emergency Management Director and Veterans Service Officer. Upon roll call vote Hewgley, Wuehler, Bruns and Woodruff voted "aye". Weems voted "nay". Motion carried.

Motion by Weems, seconded by Bruns to authorize the Chairperson to sign a letter of support for West Central Nebraska Development District Betterment Grant Application for a new vehicle. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Discussion was held concerning policies and adjustment of fees for Lincoln County Predator Control Program. Committee members reported that the program has had a positive impact in county. They want to increase the return on investment but keep the cost affordable for landowners. A different vehicle will be a substantial cost in the future and will be a budget challenge. The possibility of consolidating this program with the County Road Department or Noxious Weed Department was raised to coordinate time and personnel more efficiently. It was recommended to raise program rates now to give the county a better look at viability of the program at budget time. Commissioner Woodruff stated he felt the proposed mileage rate was still too low and suggested raising it.

Motion by Woodruff, seconded by Weems to increase the following fees for the Predator Control Program for 2025: Labor - \$50.00 per hour; Mileage - \$2.00 per mile; whole oats to \$2.00 per pound; Zinc Phosphide - \$6.50 per pound; Rosol - \$6.50 per pound; and Ammo - \$1.00 each. Force control fees will be doubled plus a management fee of \$250. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.
