Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Weems offered prayer. Wuehler called the meeting to order at 9:00 A.M.

Chairwoman Wuehler announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Woodruff, seconded by Bruns to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on February 10, 2025. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Weems, seconded by Hewgley to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

Motion by Hewgley, seconded by Bruns to approve the waiver for late filing of permissive exemption application by West Central District Health Department allowing the County Assessor to review and make a recommendation. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Equalization adjourned at 9:20 A.M. and the Lincoln County Board of Commissioners reconvened.

Brandon Myers, Region 51 Emergency Management Director, appeared to present his request for siren repairs. The city is requesting the county pay 50% for the repairs per



our contract. The county's share will be approximately \$13,000.00. The control head needed repair. Other sirens were inspected and also need repair. There will now be annual inspections of the sirens.

County Board had questions about the contract and cost share. This item was tabled for review.

Motion by Bruns, seconded by Woodruff to approve and adopt Resolution No. 2025-04 in support of Legislative Bill 37 concerning railroad safety, to be submitted to the legislature and have a representative there to testify. Committee report on the EECBG voucher program which was used on projects to improve energy efficiency in county buildings. The projects are complete, and receipts are ready to be submitted for reimbursement.
