Commissioner Bruns explained that legislation was passed which widened the radius for the port authority from ¼ mile to a 15-mile radius which would allow us to now include the North Platte Airport.

Dan Phelps and Justin Gosnell appeared to state they are very much in favor and excited about the possibility of the airport and inland port working together.

Mike Steele of the port authority board reported they want to have plans in place which includes the airport for the future. They want this to be ready so there are no hurdles at that time.

Motion by Weems, seconded by Woodruff to authorize the Nebraska International Port of the Plains (NIPP) committee (Commissioners Bruns & Hewgley) to engage the North Platte Airport Authority in discussions related to expansion of the Nebraska International Port of the Plains District. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The following bids were received for four (4) SUV's for the Lincoln County Sheriff's Office: Janssen Dodge – Bid 1) 2025 Dodge Durango V-8 - \$103,320 with trade; Bid 2) 2025 Dodge Durango V-6 - \$90,360 with trade and Bill Summers Ford – 2024 Police Interceptor Utility vehicles - \$129,497.60 with trade.

Lincoln County Sheriff's Office will review bids and make a recommendation at the March 10th Commissioners meeting.

Update on the Lincoln County Comprehensive Plan by Lincoln County Planning Administrator, Judy Clark. The plan is 80% complete in her opinion and they are working towards completion soon. Changes to the future land-use map and wind and solar energy are part of the update.
