Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Jerry Woodruff and County Clerk, Rebecca Rossell. Woodruff offered prayer. Wuehler called the meeting to order at 9:00 A.M. Commissioner Bruns absent.

Chairwoman Wuehler announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Hewgley, seconded by Weems to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on March 3, 2025. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Woodruff, seconded by Weems to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Hewgley, seconded by Weems to receive and order filed the fee reports submitted by the County Sheriff for \$6974.19 & County Clerk for \$482.00. Upon roll call vote Hewgley, Weems, Wuehler and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Weems, seconded by Woodruff to receive and order filed the certification of public tax sale 2025 as submitted by the County Treasurer. Upon roll call vote Hewgley, Weems, Wuehler and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Woodruff, seconded by Weems to authorize the Chair to sign an agreement for sale of real estate to Lincoln County from North Platte Chamber of Commerce & Development Corporation for property located at 18610 Hwy 30, Hershey, NE. Upon roll call vote Hewgley, Weems, Wuehler and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Weems, seconded by Woodruff to authorize the Chair to sign the right-of-way application submitted by Consolidated Companies, Inc. Upon roll call vote Hewgley, Weems, Wuehler and Woodruff voted "aye". Nays, none. Bruns absent.

A public hearing was opened at 10: 00 A.M. to hear comments on the proposed amendments to the Lincoln County General Assistance and Medical Assistance Guidelines.

The proposed amendments are a result of the work of the committee, county employees, community business partners and DHHS representatives.

Jada Venezie, DHHS unit manager, stated updating the fee structure to the current cost of living will allow them to assist clients.
