Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Chris Bruns, Jerry Woodruff and County Clerk, Rebecca Rossell. Bruns offered prayer. Wuehler called the meeting to order at 9:00 A.M.

Chairwoman Wuehler announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Hewgley, seconded by Woodruff to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on March 31, 2025. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Woodruff, seconded by Weems to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Woodruff to receive and order filed the fee reports submitted by the County Sheriff for \$5967.25 and County Clerk for \$757.00. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Weems, seconded by Bruns to authorize Chair to sign a right-of-way application submitted by Great Plains Communications. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The Lincoln County Board of Commissioners recessed at 9:15 A.M. and the Lincoln County Board of Equalization convened.

Chairwoman Wuehler announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

County Assessor, Julie Stenger appeared.

Motion by Woodruff, seconded by Bruns to approve the minutes regarding the Lincoln County Board of Equalization meeting held on March 31, 2025. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Bruns, seconded by Weems to approve and authorize the Chair to sign the certificates of correction or refund submitted by the County Assessor on real estate. Upon roll call vote Hewgley, Weems, Woodruff, Bruns and Hewgley voted "aye". Nays, none.

The Lincoln County Board of Equalization adjourned at 9:21 A.M. and the Lincoln County Board of Commissioners reconvened.



Ed Dunn and Ashley Neiman of West Central Nebraska Development District gave a final audit report on Lincoln County ARPA funds allocated to non-profit organizations.

Presentation on Las Mananitas Project by Adi Fernandez and MacKenzie Fernandez of the Las Mananitas Project and Executive Director, Ed Dunn, and Emma Castor of West Central Nebraska Development District.

They are requesting that the county be a pass through for a future CDBG grant application for the Las Mananitas Project. There will be no financial obligation to the county.

Discussion was held on the school resource officer program. Commissioner Weems is still concerned with the staff demand of this program. He noted that the Sheriff's Office if now fully staffed with deputies.

Sgt. Hanna reported that the Sutherland School board did agree to a three-year contract if this moves forward.

Commissioner Hewgley has concerns about Sheriff's Office vehicles and the upcoming budget year.

Commissioner Bruns asked how many calls the Sheriff's Office had responded to at Sutherland Public Schools. He also expressed concern about other schools in the county asking for the same service.

Sgt. Hanna stated Sutherland Public Schools has had an average of 126 calls per year over a three-year period and 36 calls for 2025.

Commissioner Woodruff supports the program but also feels it is the school's responsibility not the county's.

Commissioner Wuehler asked if the county had received any federal funding yet for this program.

Sgt. Hanna replied that no funds have been received. If the county does not participate the funds will be deobligated.

Sheriff Kramer stated that the deputies are needed for road patrol and daily needs. He does support the program, but if the money is not there for future funding, we need to say no.

Sgt. Hanna commented the program is for student protection as well as community policing.

No action taken on an agreement with Sutherland Public School District 55 for implementation of a school resource officer (SRO) program.



Motion by Weems, seconded by Woodruff to approve and adopt of Resolution No. 2025-09 recognizing April as National County Government Month. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.
