Motion by Weems, seconded by Woodruff to receive and order filed the treasurer's receipts. Upon roll call vote Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none. Hewgley absent.

The Lincoln County Board of Equalization adjourned at 9:16 A.M. and the Lincoln County Board of Commissioners reconvened.

Update by Paul Ottinger concerning the annexation of Pal's Brewing Company by the City of North Platte. He thanked the Commissioners for their support over the last eight years since they opened.



Motion by Woodruff, seconded by Weems to approve a 20 ft storage container with side doors for the Lincoln County Predator Control Dept. to be located at the Noxious Weed Control Dept for \$6950 delivered. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

The public hearing on the liquor license application amendment for Unreel Events LLC to add seating, a tap wall, rearranging the bar and outside seating was opened at 9:45 A.M.

Louis and Diane Herrick, the owners, were present to discuss the expansion of the building. Lou asked about perimeter fencing for the additional outside porch areas.

Commissioner Hewgley asked if the area outside would be fenced. If not, he would want to see it fenced to separate it from the public areas.

Herrick replied that the beer garden has 6 ft fencing, but the porch area currently is not fenced.

Motion by Bruns, seconded by Woodruff to close the public hearing at 9:50 A.M. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Sheriff Kramer had no objections to the application.

Motion by Woodruff, seconded by Hewgley to reappoint Jason Schultz as management representative on the Lincoln County Safety Committee for a three-year term to end June 2028. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Motion by Weems, seconded by Hewgley to reappoint Angie Forbes and Charley Wescoat as employee representatives on the Lincoln County Safety Committee for a



two-year term to end June 2027. Upon roll call vote Hewgley, Weems, Wuehler, Bruns and Woodruff voted "aye". Nays, none.

Update on sanctuary counties status by Commissioner Wuehler.

Todd Herndon, Noxious Weed Supt. and Noxious Weed Board Member, Booker Boyer, requested additional funding (\$10,000 - \$15,000) for the Platte Valley Weed Management area for helicopter/airboat spraying of phragmites on the North and South Platte Rivers in the 2025/2026 Noxious Weed Control Department budget. The state has cut funding for this program.
