

Please be advised these are sample ballots and because the law requires rotation of the candidate's names, the chronological order as listed may be different in your precinct.

Some candidates are elected in specific districts therefore, some names listed on the sample ballots may not appear on the ballot in your precinct. Lincoln County uses a DS850 ballot scanner to count ballots. The voter is required to blacken the oval. If a voter chooses to write-in a name, they are required to blacken the oval by the name they write-in for that race.
