Meeting of the Lincoln County Board of Commissioners. Present were Commissioners Joe Hewgley, Kent Weems, Micaela Wuehler, Jerry Woodruff and County Clerk, Rebecca Rossell. Woodruff offered prayer. Weems called the meeting to order at 9:00 A.M. Commissioner Bruns was absent.

Chair Weems announced the Open Meeting Act with amendments is posted for public review and the county board will comply with the open meeting requirements.

Motion by Hewgley, seconded by Woodruff to approve the minutes regarding the Lincoln County Board of Commissioners meeting held on April 27, 2026. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

No public comments were received.

Motion by Woodruff, seconded by Wuehler to receive and order filed the treasurer's receipts. Upon roll call vote Hewgley, Weems, Wuehler, and Woodruff voted "aye". Nays, none. Bruns absent.

Motion by Wuehler, seconded by Woodruff to adopt Resolution No. 2026-14 to amend the Official Zoning Map of Lincoln County, NE to rezone from a TA-1 Agricultural District to a R-1 Rural Estates District on a tract of land situated in the SW ¼ of Section 15; Township 13N; Range 31W of the 6th P.M. described as follows: Lot 1 McCall Administrative Subdivision, Lincoln County, NE. Upon roll call vote Hewgley, Weems, Wuehler and Woodruff voted "aye". Nays, none. Bruns absent.
