Village of Hershey Proposition No. 1
“Shall the Village of Hershey, Nebraska, impose a

local sales and use tax in the amount of one and one-half percent (1.5%) upon the same transactions within the Village of Hershey upon which the State of Nebraska is authorized to impose a sales tax, with all proceeds from such additional sales and use tax to be used exclusively for public infrastructure improvements, including public park and park facility infrastructure projects, street, water, sewer, and stormwater improvements, subject to the following terms and conditions:

1) Use of Tax. The proceeds from the Village sales and use tax authorized by this proposition shall be used solely for the construction, reconstruction, improvement, maintenance, and replacement of municipal infrastructure, including public parks, park grounds, playground equipment, recreational facilities, and related park infrastructure, streets, water systems, sanitary sewer systems, stormwater infrastructure.

2) Termination of Tax. The additional Village sales and use tax of one and one-half percent (1.5%) shall be in effect for a period of ten (10) years beginning on April 1, 2027 through March 31, 2037 and shall automatically terminate unless extended by a future vote of the qualified electors of the Village.

If a majority of the votes cast upon such question shall be in favor of such tax, then the governing body of the Village of Hershey shall be empowered as provided by Neb. Rev. Stat. §77-27,142 and shall forthwith proceed to impose such additional sales and use tax. If a majority of those voting on the question shall be opposed to such tax, then the governing body of the Village of Hershey shall not impose such a tax”
